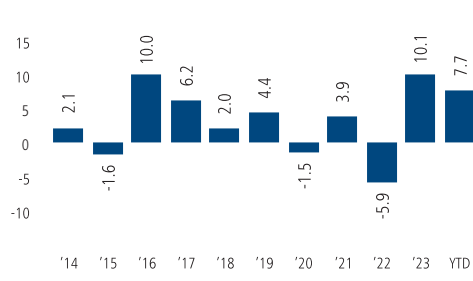

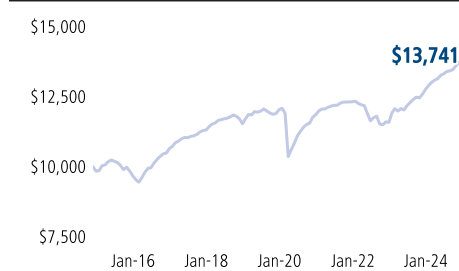

Why Invest in this fund?

- Floating rate loans offer higher yields than other short-term, fixed-rate assets.
- Floating rate loans tend to be less sensitive to interest rate fluctuations compared to fixed rate bonds.
