#### The Prospectus is amended:

- to provide notice to investors of Mackenzie Cundill Canadian Balanced Fund that a special meeting of investors will be held on or about June 5, 2025, to consider and approve proposed changes to the investment objectives of the Fund. If approval is obtained, the investment objectives of the Fund will be changed on or about June 27, 2025;
- 2) to confirm a risk rating change to the Fund Facts of Mackenzie Income Fund from "low" to "low to medium":
- 3) to reflect a change in the investment strategies of Mackenzie Income Fund;
- 4) to reflect that effective February 28, 2025, the U.S. Dollar Settlement Option became available for: (i) Series A, F, and PW of Mackenzie Emerging Markets ex China Equity Fund, Mackenzie Shariah Global Equity Fund, Mackenzie ChinaAMC All China Equity Fund, Mackenzie Global Small-Mid Cap Fund, and Mackenzie Ivy Foreign Equity Fund; and (ii) Series A and PW of Mackenzie Emerging Markets Fund; and
- 5) to reflect that certain Mackenzie portfolio managers will be added to the following Funds:

#### Accordingly, the Prospectus is amended as follows:

#### Proposed Investment Objectives Change of Mackenzie Cundill Canadian Balanced Fund

a) On page 150, by adding the following paragraph immediately below the table under the heading "Fund Details":

Notice: A meeting of Fund investors will be held on or about June 5, 2025, to consider and approve proposed changes to the investment objectives of the Fund. These proposed changes would transition the equity and fixed income ranges from the Fund's investment objectives to its investment strategies. If all approvals are obtained, effective June 27, 2025, the maximum allocation to equity securities in the portfolio will be increased from 60–70% to 60–90%, and the minimum allocation to fixed income securities will be decreased from 30–40% to 10–40%.

#### Change in the Investment Strategies of Mackenzie Income Fund

a) On page 199, by deleting the fifth paragraph under the sub-heading "**Investment Strategies**" and replacing it with the following:

The Fund's fixed-income investments are expected to have a weighted average credit quality of "**BB**" or higher, as rated by a recognized credit rating organization.

#### **Purchasers' Statutory Rights**
